The Call for Papers (Denver, 1980) has no announced deadline yet, but please be aware that the 1979 deadline was February 1, 1979.

SMT NATIONAL CONFERENCE 1980

The third National Conference of the Society for Music Theory will be held in conjunction with the AMS and CMS meetings in Denver, November 6-9, 1980. The University of Colorado (Denver) will host the combined conferences, with hotel and meeting accommodations at the Denver Hilton.

The 1980 SMT Program Committee is chaired by Richard Chrisman (Rutgers University) and includes Charles Burkhart (Queens College, CUNY), Margaret Sandresky (Salem College), Marianne Kielian (Indiana University), 1979 program chairman Stefan Kostka (University of Texas), and a member of the newly elected Executive Board to be named later.

As we all know, the success of a national conference rests on the quality of the papers and panels offered to the program committee many months in advance of the meeting time. Each year the program committees for theory conferences have read more and better proposals, and have reluctantly returned good ones because they were 1) late or 2) not constructed for aural presentation. The SMT Publications Committee will consider all papers submitted to the Program Committee, which is to say that not all papers accepted for reading will necessarily be published in *Music Theory Spectrum*, nor will the *Spectrum* refuse publications of papers not accepted for reading at a conference. Re-read the previous

complicated sentence carefully, and then note that papers and other program suggestions for the SMT 1980 meeting in Denver will have to be received by the Committee early in the year, probably by February 1, 1980.

MUSIC THEORY SPECTRUM

The first issue of the Society's journal, Music Theory Spectrum, has now been mailed to members of record for 1978 and 1979. Many compliments have been received concerning both the content of the issue, assembled by editor Bryan R. Simms, and the design, created by Joan Hantz of Rochester, New York. In its next issue (Vol. 2, 1980) Music Theory Spectrum will begin reviews of books and other serious productions of interest to theorists. Suggestions of material to be reviewed and people to review them are welcomed by the Editor.
